**Driving School Affidavit Form Instructions:**

1. Carefully review the Affidavit Form before electing a Driving School/safety program option.
2. You may pay and elect Driving School online or in person. Completed Driving School Affidavit Forms may be submitted at any Courthouse location within 30 days from the date the citation was paid, or mailed to the Clerk of Court, P.O. Box 14610, Fort Lauderdale, FL 33302-4610.
3. Enroll in a State of Florida approved Driving School/safety program and complete the course within 90 days of your election. Approved course providers can be found on the Florida Highway Safety and Motor Vehicles website [www.flhsmv.gov](http://www.flhsmv.gov).
4. File a copy of the original certificate of completion to the Clerk of Court at any courthouse location or by mail to Clerk of Court, P.O. Box 14610, Fort Lauderdale, FL 33302-4610, or via the Florida E-filing Portal [www.myflcourtagency.com](http://www.myflcourtagency.com). **Fax copies are not accepted.**

**Select a Driving School option below:** Pursuant to FSS 28.24(8) a \$7.00 fee will be charged when selecting this option.

I am eligible and elect to attend a **four (4) hour traffic course**, pursuant to section 318.14(9) Florida Statute. I have not elected to attend such a course within the past twelve (12) months, or five (5) times in my lifetime, do not hold commercial driver's license (CDL) and was not charged with exceeding the speed limit by more than 30 mph.

I am eligible and elect to attend an **eight (8) hour traffic course**, pursuant to A.O. 2014-3-CO. I am no longer eligible to attend the four (4) hour course, have never elected to attend the eight (8) hour course, do not hold a commercial driver's license (CDL) and was not charged with exceeding the speed limit by more than 30 mph.

**\*\*Statute 316.306(3)(a) – Wireless Communication Violation only.** I am eligible to elect to participate in a wireless communications device driving safety program approved by the Department of Highway Safety and Motor Vehicles. This is my first offense for this violation. Upon completion of the program, the associated costs will be waived by the Clerk of the Court and the assessment of points must be waived.

I, the undersigned, do solemnly swear or affirm that I am eligible for the option checked above. I am pleading no contest to the charge and requesting to attend a driving school/safety program.
