AGREED ORDER ON MOTION FOR CONFIDENTIALITY

The Parties have come to the Court on a Motion to Determine Confidentiality of Court Records regarding a settlement agreement and a Motion to Enforce that Settlement Agreement. Supplementary relief was requested as follows: should the Court agree that the records are confidential under Ruel 2.420, then the Motion to Enforce the Settlement Agreement should also be subject to a closed hearing.

IT IS THEREFORE ORDERED AND ADJUDGED THAT:


1. Pursuant to Rule 2.420(e)(2), the parties appeared at the April 16, 2024 hearing and confirmed that they were in agreement that the confidential records contained trade secret information.
2. That the information made confidential meets the definition of trade secret under §668.002, Fla. Stat. because it contains information that has value or potential value from not being known generally to the public.
3. That Messrs. Jonathan O'Boyle, Edward Boyle, and John P. Seiler, and Robert Reynolds shall have access to unredacted records.
4. That the duration be indefinite until the information contained in the confidential filings become public through the agreement of the Parties or upon order of release through a competent governmental body as there is no less restrictive means to keep this information confidential to

protect the trade secret information.

5. That the Clerk is directed to publish the order in accordance with Rule 2.420(e)(4).
6. That Defendant's Motion to Enforce the Settlement Agreement be entertained as a closed proceeding.
